ELECTRIC RATES

RESIDENTIAL SERVICE RATE

RATE NO. 2019 - 14, 17

Availability

Available to any residential customer in a private residence for domestic purposes only where 120/240 volt single-phase electric service is provided through a single meter. Service is available to residential customers within the City of Princeton and applicable adjacent rural areas.

RATE

Customer Charge

\$15.00 per month

Energy Charge

For all kWh per month

\$0.1245 / kWh

Energy Cost Adjustment

Each monthly bill may be adjusted by the difference in the revenues collected and the actual revenue requirements incurred in the previous month.

Minimum Billing

The customer charge is the minimum charge. The energy charge is in addition to the customer charge.

Prompt Payment Provision

A charge of 10% will be added to the bill if payment is not received by the due date.

Other Terms and Conditions

The rate shown above is subject to MN state sales tax and Mille Lacs County or Sherburne County tax if applicable.

SMALL COMMERCIAL GENERAL SERVICE

RATE NO. 2019 - 18

Availability

Available to any commercial, industrial, or institutional customer, including non-profit entities, for combined lighting and power service provided through one meter. Service is available to commercial customers within the City of Princeton and applicable adjacent rural areas.

RATE

Customer Charge

\$20.00 per month

Energy Charge

For all kWh per month

\$0.1295 / kWh

Energy Cost Adjustment

Each monthly bill may be adjusted by the difference in the revenues collected and the actual revenue requirements incurred in the previous month.

Minimum Billing

The customer charge is the minimum charge. The energy charge is in addition to the customer charge.

Prompt Payment Provision

A charge of 10% will be added to the bill if payment is not received by the due date.

Other Terms and Conditions

A demand meter shall be installed when a customer's monthly kWh use exceeds 7,500 kWh for 2 consecutive months.

If a demand meter is installed, a customer will remain on the Small General Service Rate schedule as long as the customer's maximum demand is less than 25 kW. When a customer's maximum demand is 25 kW or greater for 5 consecutive months the customer will be placed on the Large General Service Rate.

The rate shown above is subject to MN state sales tax and Mille Lacs County or Sherburne County tax if applicable.

COMMERCIAL / INDUSTRIAL LARGE GENERAL SERVICE RATE

RATE NO. 2019 - 19

Availability

Available to any commercial, industrial, or institutional customers, including non-profit entities, as single business establishments for all power and lighting requirements, when all service hereunder is provided through one set of meters at a single point of delivery. Service is available to commercial customers within the City of Princeton and applicable adjacent rural areas.

Applicability

To commercial, industrial, or institutional customers for combined power and lighting purposes. Service will be rendered at the utility system standard secondary voltage, single or three phase, or at primary voltage designated by the utility system as the service voltage available in the area for the size of the load to be served. This rate shall be applied to loads in excess of 25 kilowatts (kW) but less than 1,000 kW.

RATE

Demand Charge

For all kW per month \$15.35 / kW

Energy Charge

For all kWh per month \$0.07 / kWh

Minimum Billing

The demand charge for 25 kW plus the energy charge for all kWh used.

Prompt Payment Provision

A charge of 10% will be added to the bill if payment is not received by the due date.

Other Terms and Conditions

Additional transformers not located at the point of delivery and special voltage transformers for lighting and other purposes shall be owned and maintained by the customer.

A customer with a maximum demand of less than 25 kW for 12 consecutive months will be placed on the Small General Service Rate schedule. Upon customer request Princeton Public Utilities will review customer's service rate.

When a customer's maximum demand is 1,000 kW or greater, the customer will be placed on the Large Power Service Rate schedule in the next billing month.

COMMERCIAL / INDUSTRIAL LARGE POWER SERVICE RATE

RATE NO. 2019 - 20

Availability

Available to any commercial, industrial, or institutional customers, including non-profit entities, as single business establishments for all power and lighting requirements, when all service hereunder is provided through one set of meters at a single point of delivery. Service is available to commercial customers within the City of Princeton and applicable adjacent areas.

Applicability

To commercial, industrial, or institutional customers for combined power and lighting purposes. Service will be rendered at the utility system standard secondary voltage, single or three phase, or at primary voltage designated by the utility system as the service voltage available in the area for the size of the load to be served. This rate shall be applied to loads in excess of 1,000 kilowatts (kW).

RATE

Demand Charge

For all kW per month \$15.35 / kW

Energy Charge

For all kWh per month \$0.0624 / kWh

Energy Cost Adjustment

Each monthly bill may be adjusted by the difference in the revenues collected and the actual revenue requirements incurred in the previous month.

Minimum Billing

The demand charge for all kW used plus the energy charge for all kWh used.

Prompt Payment Provision

A charge of 10% will be added to the bill if payment is not received by the due date.

Other Terms and Conditions

Additional transformers not located at the point of delivery and special voltage transformers for lighting and other purposes shall be owned and maintained by the customer.

A customer with a maximum demand of less than 1,000 kW for 12 consecutive months will be placed on the Large General Service Rate schedule.

Energy Charge

For all kWh per month

\$0.1245 / kWh

Prompt Payment Provision

A charge of 10% will be added to the bill if payment is not received by the due date.

AREA AND SECURITY LIGHTING SERVICE RATE
RATE NO. 2019 - 3, 4

Availability

Available in the City of Princeton and applicable adjacent rural areas for year-round illumination for area and security lighting by electric lamps in luminaries supported on wood poles, where the facilities for the service are furnished by the utility.

Security light, up to 100 watt or equivalent	\$ 8.95 per fixture per month
Security light, 250 watt or equivalent	\$ 15.30 per fixture per month
Security light, 400 watt or equivalent	\$ 20.50 per fixture per month
